the Company’s Revision to its Dividend Estimate

At the executive board meeting of the Company held on April 9, 2026, the Company decided to revise its dividend per share estimate for the year ending August 31, 2026. The decision is detailed below.

1. Reasons for the dividend forecast revision

Based on the recent revisions in consolidated business estimates for the year ending August 31, 2026, the Company has revised its year-end dividend per share estimate from 270.00 yen to 320.00 yen. Consequently, the estimated total dividend per share has been revised from 540.00 yen to 640.00 yen.
